A. REGISTRATION FEES: **\$525.00** *Are not refundable or transferable*

Registration is a yearly fee of \$525.00 per student.

Registration includes: morning supervision (starts 7:00), planner, P.E, and all additional fees for running a school.

B. ANNUAL TUITION FEE SCHEDULE

Family rates apply to students in grades TK – 8 grades. In order to qualify for the family rate, students must have at least one parent or legal guardian in common and/ or be claimed as dependents on the same tax form. Tuition rate is not based on months attended, but a yearly flat fee divided into payments. The number of payments is 1 to 11 months maximum.

Tuition is due on the 5th or the 20th of each month from August 5th through June 20th. All payments must be paid through TADS Tuition Management, it is mandatory to enroll online with TADS. TADS has a one time yearly fee for the year of \$49.00.

Families who do not enroll with TADS will be charged \$25 for tuition payments made in the school office.

DELINQUENCY OF PAYMENT after the due date will accumulate a weekly late fee of \$25 to your account a total addition of \$100 for each month a payment is late and may result in termination of enrollment, hold on student report card and records as well as collection procedures and reporting to credit bureaus.
